### Chatfield Junior Open July 10, 2010 Official Notice of Regatta

You're invited to race in the Chatfield Junior Open Regatta on July 10, 2010, hosted by the Colorado Sail & Yacht Club in the Roxborough Cove of Chatfield Reservoir. You will need to bring or arrange for a boat to race.

Registration starts at 9:00 AM at Roxborough Cove which is east of the Marina and South Ramp (see attached map). Sailing Instructions will be distributed to competitors at Registration. A competitor's meeting will be held at 9:45 at the same location to announce fleets and starting order. The entry fee is \$5.00, which includes a lunch. There will be several races, the first one is anticipated to start at 11:00; there will be a lunch break and racing will resume after lunch. No race will be started after 3:30 and awards will be presented after racing.

There will be a juniors-only fleets for those who have not reached their 19<sup>th</sup> birthday by January 1, 2010 and an adult/junior fleet with one adult plus juniors aboard. The Racing Rules of Sailing will be used.

Rules: Races will be governed by the rules as defined in The Racing Rules of Sailing (RRS). Sailing instructions may modify rules as permitted in the RRS

Eligibility: Competitors who have not reached their 19<sup>th</sup> birthday by January 1, 2010 are eligible to participate. Eligible boats are single-handed and double-handed monohull dinghies. Each boat must display sail numbers which shall not be the same as sail numbers of other boats in its fleet. There will also be a mixed adult child fleet where an adult can race with children.

Entries: Entry may be made by completing and submitting the enclosed entry form with parental consent and paying the entry fee (see instructions on the form). Competitors may also be required to register with Community Sailing of Colorado if they wish to use a loaner boat.

Classes/Fleets: Fleets will be determined by the race committee following registration.

Notices to Competitors: Notices to competitors will be posted on the bulletin board at the Registration Tent. Notices will include classes/fleets and start order, any changes in schedule or sailing instructions, and protests if any.

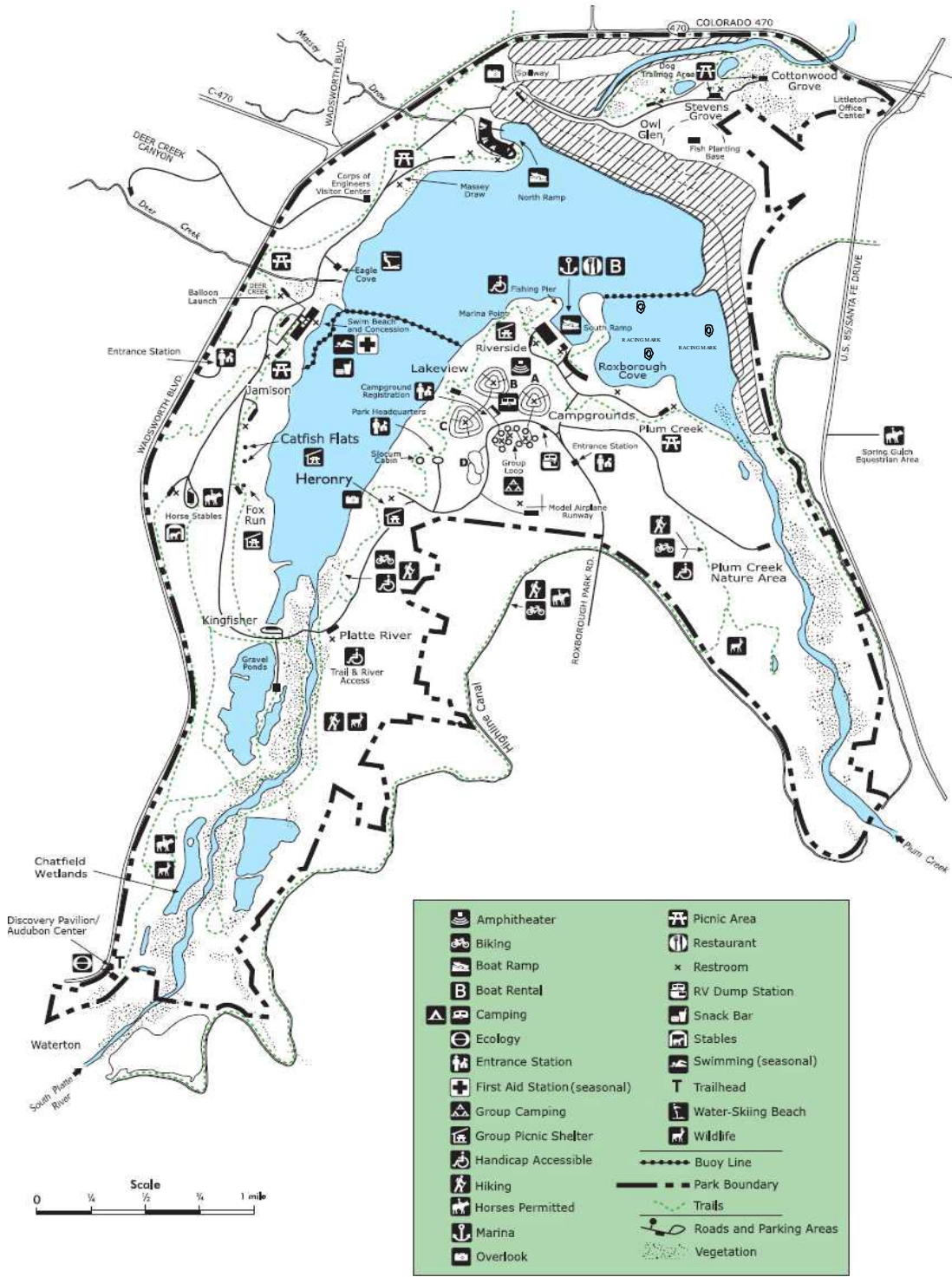
Signals Made Ashore: Will be made in front of the Registration Tent.

Sailing Instructions: Sailing Instructions will be distributed at Registration and will be posted by June 30th on the Colorado Sail and Yacht Club website, <http://www.csyc.org>. The Race Committee may, in the sailing instructions, modify the Racing Rules as permitted by the RRS. Courses to be sailed will be described in the sailing instructions.

Scoring System: Mixed fleet (different kinds of boats) races will be scored by Portsmouth handicap. The regatta will be scored using the Low Point System in Appendix A of the RRS, as modified in sailing instructions. If only one race is completed, there will be no discarded scores – this changes Appendix A2.

Prizes: Trophies will be awarded based on the number of competitors in each class. Scores will count toward the SAIL Tour Junior Trophy for 2010.
